
Subject: GOT SOME COOKIES - ALL THE CROOKS ARE GOING DOWN TODAY! - RE: Please watch these short videos

Your action of choosing to write me is not lost on me; there are issues that you have yet to address which prevent me from allowing you into my life.

If your children don't see you as fallible, then when they/we fail, as everyone does, we won't know how to pick ourselves up. Additionally subconsciously the inaction of addressing your failure makes a child feel that they are inadequate for failing where they assume without knowing differently, that their parents and role models were successful. It conditions a child to be critical of themselves in an unnecessary way.

Knowledge is not only the awareness of but is intended for practical application so that in the case of a parent and child; a parent can bestow what they learned about life as a road map so that their child can avoid the same pitfalls. Thank you for writing me.

I hope you know that I hold no anger inside towards any of the people that I confronted. I do wish that I would have confronted each person at the time the events happened, so that I didn't have to carry everything for so long, but I had to bring order to my life and I started with my mind, addressing everything that I had lied about to myself.
