
**Subject:** THE END JUSTIFIES THE MEANS

There should be a little introduction-chronology and this may suffice, that begins with my mother visiting Israel in July 2001 and writing me this letter on King David Hotel Stationary.



Then on October 9<sup>th</sup>, 2001, the day after I attend a Board Meeting of the Wetherly Capital Group headquartered in west Los Angeles,
