Mr. Gates said he had abandoned certain positions he once held on certain national security issues. Asked about an article he wrote in 1994 advocating a military strike against North Korea's nuclear facilities, Mr. Gates said he had changed his mind about how to deal with the communist country's burgeoning nuclear program.

“I believe that clearly at this point the best course is the diplomatic one,” he said.
