Thanks for the invitation to join you.

This email address: dfiske@gia.edu is at work in Carlsbad. It's principally a weekday, workday means of communication. I occasionally access it remotely from home, which I did Sunday but too late to take you up on your invitation.

My experience in China is quite limited (two weeklong visits), but it's enough to get a feel for the place, the people and their ethics. A good friend has traveled to China on business scores of times in the past 10 years. He has no illusions. Whatever affection and rapport he might once have had with Chinese businesspeople has long since been buried by the people themselves. I have faith in his impressions.

I used to work with a very successful Chinese immigrant in the Los Angeles area. He came here as a refugee in the early '50s, worked his tail off, realized the American dream, and put three children through USC. One has a master's degree in library science, another is an MD, and the third took over the family businesses. Having worked with him gave me a preview of dealing with people in China. Something they all have in common: They want to feed you. I don't think the motive is solely generosity.

You sent a great deal of information that would take a very long time to read closely. I've scratched the surface, but Monday morning does not lend itself to deep diving. Generally, I do my housekeeping and mindless work then as I wait for my mind to get out of weekend mode and back into the business fray.

Perhaps we can get together another time?
