When scrolling down the "\$ Hit List" on www.just3ants.com you will come across the name Dr. John Ben Stewart MD, also known as The IT aka The Sperm Donor.

When clicking on the hyperlink above The IT's name you will come across one of my responses to an email sent from his one email account which reads:

Fuck off Gary - this is not the sperm donor but Dawn. If you would like to confront me - be foolish enough to. I am about two feet taller than you and will chew you up and spit your stupid ass out. You have been sucking life off of everybody you latch onto you POS (piece of shit). Each day I pray Marie will get a voice from God to dump your stupid ass because she could do a lot better. What? The alimony and child support petering out you pathetic loser. John is an honorable man, has supported kids well, and you are just a lowly opportunist. Go to your hill in the mountains and talk to the animals. Now stop violating the restraining order before we get another one.

Not long after Dr. JBST MD filed a baseless criminal complaint - highly suggestive of abominable sexual misconduct against a minor - directed at me, but mostly aimed at my wife, back on September 11th, 2002, the first anniversary of 911, this slimeball of slimeballs then, 3 days later, on September 14th, 2002, sent me a "coded" email that simply read in the subject line, "**Re: RE**".

This not in the least bit "error" email was in fact a violation of the Temporary Restraining Order The IT managed to get on 9/11/2002 against me even though

the authorities down at the courthouse in downtown San Diego didn't even bother to first contact The IT's second Ex-wife, my wife Marie Dion Gevisser, to find out a little more "history" about this slimeball of slimeballs that he had managed to mask rather well when "trapping" French-Canadian MDG.

Back on September 11th, 2002, I was 45 years of age, not 40, and in pretty good physical condition.

My weight was about 140 pounds, the same as it is right now; no different to when I was 15 years of age, also in pretty good physical condition but not quite as fit and strong as I was in my mid-20s when my weight had increased to 150 pounds and my body fat percentage like it is right now, rather low, actually significantly below most phatsos like The IT and Dawn; not to mention you would know of the strong correlation between obesity and dementia; to mention little of The IT's genital herpes and how he got it, let alone how it would hinder that much more The IT keeping track of his lies from day one.
