World-number one diamond-miner De Beers has agreed to pay \$295-million to settle a class action in the US to "put the issues to bed", but denies any wrongdoing.

"The decision to resolve this matter is consistent with our continuing commitment to being a modern De Beers that is able to meet the challenges of a world-class diamond company in a dynamic and fast-changing business environment," spokesperson Lynette Gould said in an email on Friday.

"While De Beers denies the allegations, and has therefore not admitted any wrongdoing, we have chosen to settle because we believe it is in the best interests of consumers, the industry and our business to resolve these allegations and move on," she added.

This came after a class action suit alleged that, during the period January 1, 1994, and March 31, 2006, De Beers monopolised and controlled the supply of rough diamonds in violation of certain US federal and State laws and, as a result, caused the prices of rough diamonds to be higher than they otherwise would have been.

The settlement resolved all outstanding class actions against De Beers in the US, the firm said.

The company supplies about half of the world's rough diamonds.

It was founded in Kimberley in the 1970s by legendary entrepreneurs **Cecil Rhodes** and **Charles Rudd**.
