Subject: Darfur - China

Dad.

Why did you decide to donate money to Darfur?

Were you aware that Darfur is the Sudan's third civil war since 1955? The last one was encapsulated in a documentary called GOD GREW TIRED OF US; but was basically about the mainly Muslim North against the mainly Christian South. I am assuming that you didn't hear of it, because we didn't have the same media coverage or celebrities rallying against it as we do now in Darfur.

There is another interesting documentary which is about Darfu, called THE DEVIL CAME IN ON HORSEBACK.
