Adam,

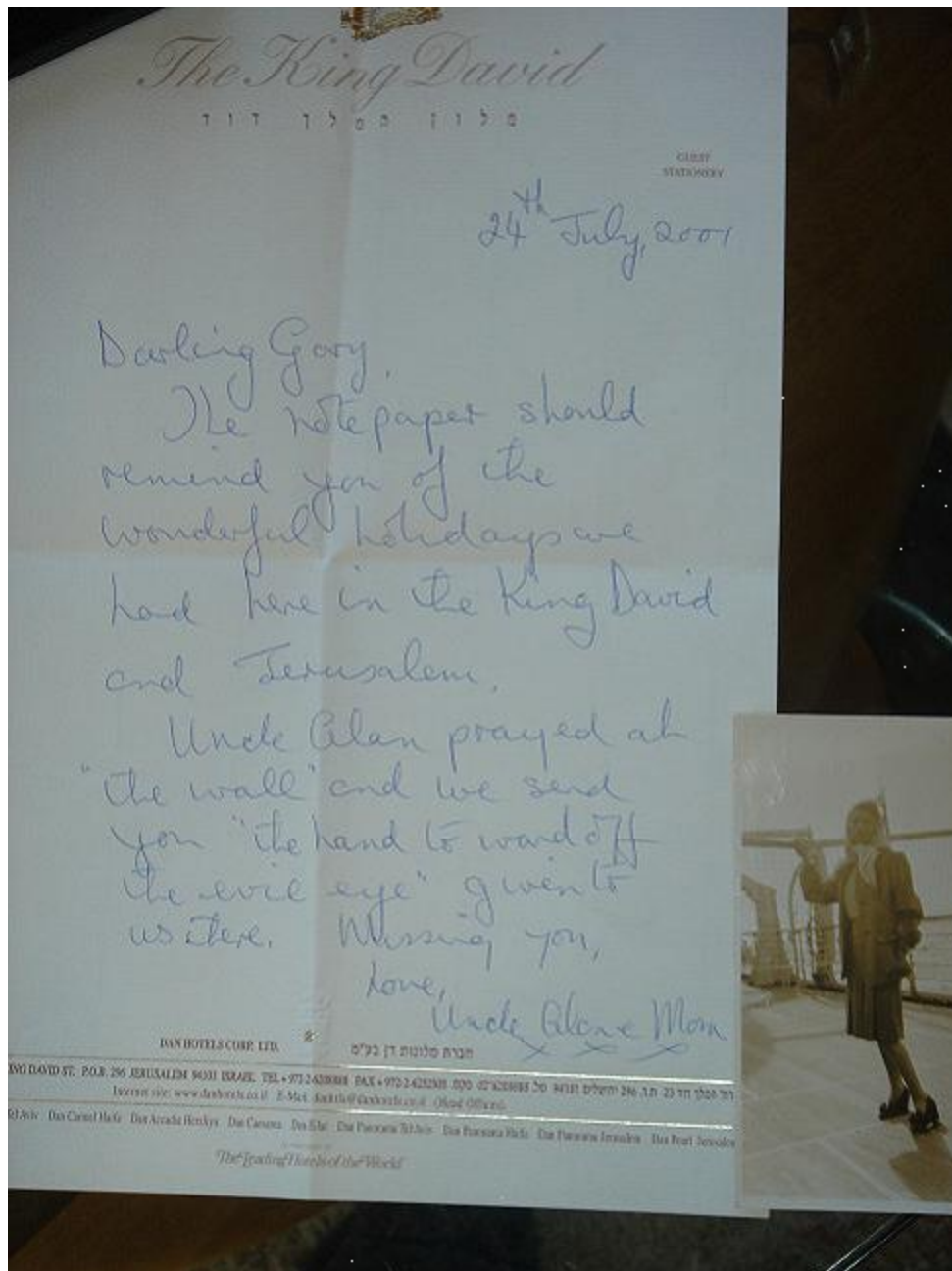
Don't be afraid to share with him the truth, the whole truth and nothing but the truth so help...---...

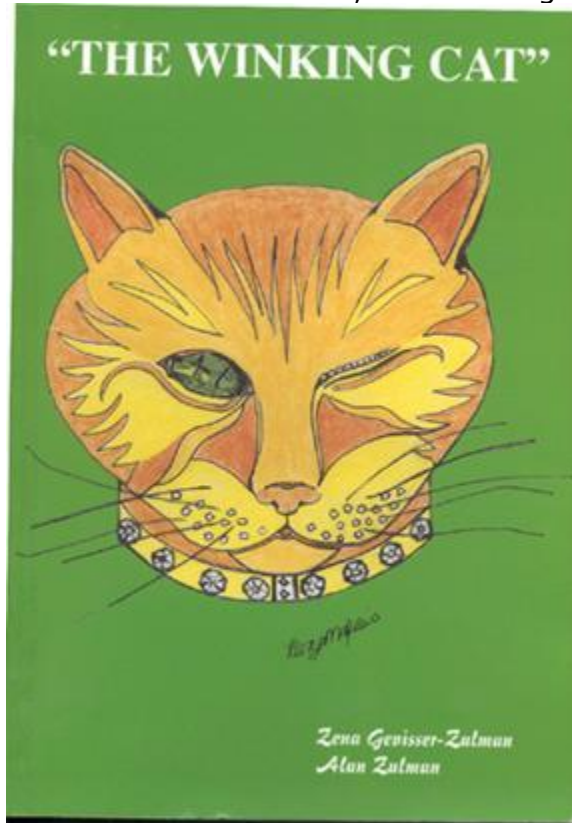
