Noam,

I first became aware of you when Alan Dershowitz replied to one of my emails stating that I was from "planet Chomsky". I won't get started on what I think of him but I can thank him for bringing your work to my attention.

Are you familiar with FBI Agent Robert Hanssen who was arrested in 2001 and arguably responsibly for the worst security breach in US history? What most don't give a second thought to is that he was paid by in large with diamonds.

Most would not think of diamonds as a currency but the Be Beers Anglo American pricing mechanism and monopoly creates a universally valued, untraceable, unregulated currency that is capable of usurping all regulatory agencies and can pass undetected through customs making it an ideal vehicle for money laundering.

In 2001 I met a Jewish South African while doing a computer consulting assignment. I later learned of his long familial history rooted in the survival of Israel, starting with his Maternal great grandmother Neche Badash who's family was slaughtered by Cossacks while she helplessly watched hidden in a closet at the age of 8. She survived this pogrom in the same small village as David Ben-Gurion who you undoubtedly know as the first Prime Minister of Israel and leader of the less militant Jewish Underground, the Haganah.

Gary S. Gevisser, my close South African friend first met with David Ben-Gurion while on Ulpan at Sde Boker on November 1, 1972. While Gary maintains that he is neither an official or unofficial member of Israeli Military or Mossad's intelligence gathering forces, he is Israeli Special Forces trained and Intelligence Trained and has many close ties with Israel and members of Israel's Maritime Special Forces unit, Flotilla 13 and other Israeli Special Forces units.

Neche was very close to Ben-Gurion and I believe acted as a runner for him well before and after her granddaughter, Gary's mother Zena was born in England back in 1929, when Nechie returned from Tel-Aviv, Israel where she was an early resident, to raise Zena whose father Alef Badash who changed his name in September 1939 to Al Ash was a very successful trader who in 1947 decided to immigrate to South Africa "hot on the heels" of the victors, those who had profited handsomely from World Oil War II.

I am not exactly sure when Nechie died or how she died but it was likely before the onslaught of the British White Papers, prior to Israel's War of Independence which prevented men of military age from entering Palestine; such an obscene act by the victors of World War II very telling of their "sentiments" towards those Jewish people who had survived let alone the 6 million so brutally and systematically slaughtered.

The boycott imposed on the Jews of Palestine and eventually the State of Israel in the form of the 1939 British White Papers, left this fledgling Jewish State essentially defenseless as it was not only enforced by Great Britain but by the US government as well; the inhuman embargo limited Jewish emigrants from entering British controlled Palestine to just 10,000/year; at a time when Jews were trying to flee Nazi Europe with Auschwitz alone killing some 10,000 Jews per day.

On March 17, 1978, Gary arrived in the United States armed with two letters of introduction; one for the attorneys of Engelhard Minerals & Chemicals Corp. and one for a former senior member of Acme Timber, a previous subsidiary of the South African Moshal Gevisser Group, a multi-national trading conglomerate that played an integral role in smuggling weapons and Jews into Palestine during the enforcement of the British White Papers of 1939.

Not to mention Gary's one grandfather Israel Issy Gevisser, who co-founded The Moshal Gevisser Group of Companies in 1910 owned in both his as well as his sister's name priceless land in Haifa Harbor purchased well before the rise of Nazi Germany; not to mention Issy's sister Pessiah and all her children and grandchildren were ultimately murdered by the Nazis; in 1969 the American Charles Engelhard and his Anglo South African partner Harry Oppenheimer orchestrated the liquidation of the Moshal Gevisser Group given how such a trading organization that not only had an extraordinary reputation around the world for being both smart and honest also fostered entrepreneurialism amongst in particular non-white South Africans, the last thing the De Beers Group wanted.

If you are not familiar with the name Charles Engelhard Jr. you may know of his likeness which was represented in the James Bond movie Goldfinger, the Goldfinger character said to be modeled after Engelhard who was known for smuggling gold out of South Africa by forming it into art work and shipping it to Hong Kong to then be melted back into gold bullion. His tight relationship with Harry Oppenheimer of De Beers Anglo American is well chronicled in the non-fiction DIAMOND INVENTION, ch18 - THE AMERICAN CONSPIRACY, written by investigative journalist Edward Jay Epstein.

What you probably don't know and won't be able to read about was that Engelhard's untimely death at age 54 was at the hands of Mossad. Gary's mother Zena Gevisser would say that he died of an overdose of Coca-Cola which he always had a case of when visiting the headquarters of Moshal-Gevisser Group during his many visits to South Africa; Engelhard's trips eventually leading up to the dissolution of this very successful trading conglomerate at liquidation prices due to the role of De Beers.

Gary's "Uncle" David Gevisser, who is actually his father's first cousin, was "placed" as the executor of the estate of Charles Engelhard Jr. who had no male heirs. So when Gary arrived in the US armed with his letter of introduction for the Engelhard attorneys located on Bush Street in San Francisco, Gary was "placed" with a nothing-to-speak of job at Codiam Inc. located on 47th Street New York, also known as the "diamond district". Stephen Cohen the CEO of Codiam Inc. was and most likely still is a "site holder" which is a first tier direct buyer from De Beers; one of a couple hundred in the world.

De Beers executives have not been allowed to set foot on US soil because of their known business of price fixing, which makes the meeting that Harry Oppenheimer had with President Elect JFK all the more curious until you look at the culpability of the US Justice Department and the three branches of the US government. Gary was expected to one day replace his "uncle" David Gevisser as the American leg of De Beers, and was trusted accordingly. During his employment with Codiam Inc., Gary attended private meetings between Stephen Cohen and Martin Rapaport who publishes "The Rapaport Report" an international price setting publication for wholesale cut diamonds. It was during these meetings that Stephen would provide Martin with the prices provided by De Beers to then be published across the world. All of these meetings conducted over deli sandwiches delivered to their office.

In 1980, just a couple of months after Gary joined Codiam Inc. where there was "no job to speak of" Gary began to fall ill, which was disconcerting considering he was only 23 years of age and otherwise very healthy and extraordinarily fit. After being examined by US doctors with no results, his very secretive mother had him return to South Africa to be eventually seen in Durban, South Africa by a top gastroenterologist, and close family friend. Barely able to walk by this time, this physician, simply relying on both a lymph and liver biopsy done at Groote Schuur hospital in Cape Town

concluded that his liver had most likely been purposefully poisoned. Thankfully he was able to be nursed back to health and when he recovered he called Stephen Cohen who was audibly shocked to hear Gary's voice and in that same phone call quickly informed Gary that there was no position waiting for him; not to mention the gastroenterologist, Dr. Michael Moshal within a few days of diagnosing Gary's damaged liver as well as how it had been poisoned and concluding along with Gary not to breath a word to anyone until more evidence could be "unearthed", was diagnosed with terminal lung cancer despite having never smoked a cigarette in his life and was dead and buried within a year; some 10 months after Gary received this last letter from him.

Gary returned to the US, but kept very quiet about what he had learned and witnessed while working with Codiam. He then went on to do "workouts" in mostly private corporations way off the "radar screen" of De Beers given their access to Wall-47<sup>th</sup> Street that comes with their unbridled access to unlimited amounts of untraceable, lightweight and never inventoried diamond currencies always price fixed at more than a De Beers drilling bit and a barrel of oil to boot; it wasn't long given his above average command of numbers which combined with his intelligence training that would not only have him remain "safe" but be sought out by private investors who for their own reasons wanted to stay off the radar screen including distinguished clients such as the William A Randolph Hearst Jr. who in 1993-1994 when Gary was engaged to do number of "sensitive assignments" was the Chairman of the Board of Hearst Corporation; not to mention that in 1989-1990 Gary headed up the restructuring team of a onetime highly successful US based personal care products company whose single main product, the Epilady Womens shaver was engineered and manufactured on a Kibbutz in Israel and as you can imagine despite extraordinarily large profit margins that didn't go unnoticed by the Chinese there was not a single knockoff ever shipped into the United States, and Gary says he wouldn't have been at all that surprised if a single knockoff was ever manufactured.

It is worth noting that the greed as well as the brute military tactics of the De Beers Group was not left unnoticed by David Ben Gurion who knew that the only to beat them was to be not only more deceptive but when necessary as equally brutal, willing to take on their own whenever necessary – Suzannah Operation, summer 1954.

It wasn't until the internet became such a strong medium that Gary decided to begin sharing his intimate knowledge of De Beers, which is about when I

met him in early 2001. I was hired as a computer consultant and he paid me hourly to help him with his computer needs. He talked a lot and since he was paying me by the hour, I listened. I didn't think much of what he said at the time, since I was so used to people talking for the sake of inflating their importance, and so was Gary at least equally aware and no doubt using me to gauge his ultimate audience which is each and every poorly conditioned human being in the world who is as Gary would say, "as good as the last person they speak with."

It was only in mid-2003, following a meeting with one of his clients, Mr. Jeffrey R. Krinsk Esq. of Finkelstein & Krinsk when they were discussing whether or not to accept a US\$10 million class action lawsuit that Gary had "engineered" against Revlon Corporation and its Chief Executive Officer Ronald O. Perelman, that Mr. JRK suggested that Gary use his "talents" to now bring down De Beers by first "cutting off all the limbs, the head and not to forget quartering the torso".

Again, back in 2001 De Beers was nowhere on the radar of what Gary discussed with me, but certainly 9/11 was; and in early 2002 Gary had me assist him launch his second website, [www.NEXTtraterresTRIAL.com](http://www.NEXTtraterresTRIAL.com) and loading up on to this website carefully selected emails, many of which were incredibly personal as well as being "all over the board".

But it began his dissemination of the information which was carefully hidden in oftentimes long missives with lots of distractions, enough distractions to allow any normal person to dismiss his writings as little more than that of a person verbalizing their rants normally relegated to their own mind.

What no one knew, was hidden in the midst of his verbal diarrhea were morsels of meat that when put together acted as an insurance policy allowing De Beers who would eventually catch on to see no benefit in killing him since the information was already circulating the web, and cached on the search engines.

It wasn't until late 2004, that Gary reintroduced himself to De Beers and informed them in no uncertain terms that he had been communicating with the office of Attorney General Elliot Spitzer to be later known as "client #9". Of course "client #9" and his office staff did nothing to investigate neither Gary's very credible history nor his information against De Beers.

When you examine the past 100 years of history regarding the modern day money you start to see the repeated appearance of the name JP Morgan not only as a war financier/profiteer but his role in the formation of the Federal Reserve System as well as being a cofounder of Anglo American alongside

Ernest Oppenheimer; Anglo American took control of De Beers Consolidated Mines in 1929 by using a stockpile of diamonds and the threat of flooding the market which would have collapsed the price of diamonds. This leverage allowed Ernest Oppenheimer to gain the position of chairman and head of the newly formed De Beers Anglo American.

When you consider the power of an untraceable light weight, unregulated currency, you begin to see the potential applications of a currency which leaves no money trail and can conveniently pass through customs in diplomatic pouches that can in fact be as large as super oil tanker.

During WWII a Dutch South African named Jan Smuts held the title Field Marshall and was second in command to Winston Churchill. At the beginning of his career, Jan Smuts spent a little over a year working for Cecil Rhodes, the founder of De Beers Consolidated Mines. When Jan Smuts realized the role that Rhodes was playing in the Jameson Riots in South Africa as a means of using British colonialism to take over the mineral rich land of South Africa, Smuts left Cecil Rhodes and during the Anglo Boer War of 1899-1902 he had the opportunity to lead the Boer farmers in fighting the British colonials. This was the first war that JP Morgan financed and if it wasn't for the British use of concentration camps against the Boer women and children, Great Britain would not have been successful as they had great difficulty fighting in the South African climate and terrain and against incredibly disciplined and well trained guerrilla "fighters" [sic], expert rifle shot on horseback; not to mention that Churchill himself was captured by Boer Commander Louis Botha.

The Federal Reserve System was founded in 1913 and in less than one year of its formation, WWI broke out and offered JP Morgan once again, another opportunity to greatly profit from war, leveraging his access to the Federal Reserve Banks to lend well over US\$100 million to the Allies.

In war money is no object and during peaceful periods those who print money and who have the backing of the military can use such monies to buy lawmakers and use their lawyers to steal legally.

As technology increased so did the demand for industrial diamonds which were essential for the precision tooling necessary for mass production of anything steel. Thanks to documents released by the Freedom of Information Act we learned that when Roosevelt decided to enter the war his administration concluded that they did not have enough industrial diamonds to convert US factories to war time production which eventually resulted in investigation by the OSS to determine the source that was responsible for limiting the United States access to this much needed wartime material.

During their investigation the OSS determined that tons of diamonds were being shipped to the Nazis and were being sold at a price that was well above the present market at that time.

As military production increased in the United States, so did the demand for industrial diamonds. The United States requested additional diamonds, but De Beers refused. It was only when Roosevelt refused to ship airplanes to GB that the British War Ministry was able to pressure De Beers to eventually acquiesce.

During this whole back and forth, Field Marshal Jan Smuts was witnessing the power of his onetime employer De Beers and realized that De Beers influence was far reaching in the British War Ministry. It is assumed that it was this realization that prompted his decision to aid the Jewish Underground in opposing De Beers and their Allies. If Jan Christian Smuts had not been supplying David Ben Gurion and the Jewish Underground with the strategies of the opposing British and American supplied Arabs, it is unlikely that Israel would have been able to allocate their very limited military resources to have defended themselves and survived.

Not to mention in 1932 Jan Smuts went along with a Kibbutz in Israel named after him.

In addition to precision tooling, industrial diamonds have afforded De Beers control of the world's drilling industry which as you know is essential for accessing any minerals or deposits such as oil that are buried deep within the earth.

If you follow the money trail which has been afforded because of the perspective gained with the passing of time one begins to see a clear path that leads to De Beers being the world's allocator of both natural and human resources.

De Beers realized long ago that if they supply all sides including their opposition, they will always be in good graces. Should a government decide that they want to nationalize their natural resources, De Beers simply supplies diamonds to their opposition and the next thing you know there is a civil war and the government that once opposed De Beers, now requires the revenue from De Beers mines to fight their civil war. Once one realizes how easy it is to start a civil war one begins to understand why the mineral rich countries of Africa are in a constant state of war.

I am sharing all of this with you because you are someone that has spent a lifetime questioning the status quo and you have access through MIT to reach some of the greatest minds that have yet to be corrupted.

The last 3 generations of Americans have been driven to war under the pretense of spreading freedom and democracy; but the words that fall from the mouths of our politicians that lead us to war, are seldom reflected in our actions and end results.

Here is a transcript from a discussion between President Johnson and Greek Ambassador, Alexander Matsas, on June 1964 following Ambassador Matsas's refusal to agree to the US Acheson plan for the partition and 'double enosis' of Cyprus

"Then listen to me Mr Ambassador. Fuck your parliament and your constitution. America is an elephant, Cyprus is a flea, Greece is a flea. If these two feckless fleas continue itching the elephant they may get whacked by the elephants trunk, whacked good& We pay a lot of good American dollars to the Greeks Mr Ambassador. If your Prime Minister gives me talk about democracy, parliament and the constitution, he, his parliament and his constitution may not last very long.

Three years later in Greece:

**1967:** A CIA-backed military coup overthrows the government two days before their elections. The favorite to win was George Papandreu, the liberal candidate. During the next six years, the "reign of the colonels" - backed by the CIA - usher in the widespread use of torture and murder against political opponents; honoring President Johnson's threats to Greece.

It is important to remember that President Johnson kept the United States in Vietnam from 1963-1969. It is obvious from his words to the Greek Ambassador Alexander Matsas that Johnson had no regard for the democracy or rights of other nations yet used the rhetoric to justify military funding and the deaths of close to 50,000 Americans and over 300,000 Vietnamese.

The idea that we entered the war in Vietnam under the pretense of fighting communism and bringing Democracy and freedom to the Vietnamese is hypocritical to say the least when you consider it was at a time when black people in America were still fighting for their own civil rights and freedoms yet were drafted to fight and die for the freedoms of others in foreign lands.

At this moment, we the United States of America have military occupation in 130 out of 190 countries across the world. These occupations have been supported by we the people under the guise of spreading peace, but few will argue the statement that is sent to the civilians and the governments of these occupied countries as they quickly realize that the presence of a foreign military sends a clear message that they better comply with US because we are already in their backyard.

I am writing this to you to appeal to your common sense, humanity and pride as an American. Ignoring a problem never results in a solution; the culmination of our collective ignorance and denial is today reflected in the state of our union and our struggling economy. The work ethic that founded this great country has been replaced with complacency and denial. We are beyond the point of repair and we are all left with a difficult decision; Do we carry on with business usual and drown with our sinking ship or do face the truth of what we have allowed our country to become, and demonstrate to the rest of the world that our government has been representing their personal interests above that of its people.

A government should fear its people for we have the power to replace them. If we do not stand up to our government the rest of the world will view our lack of action as complicity and agreement; and as our dollar collapses and we can no longer afford to maintain our military intimidation, we will be judged based upon our actions against the world and our inaction as American citizens to stop it.
