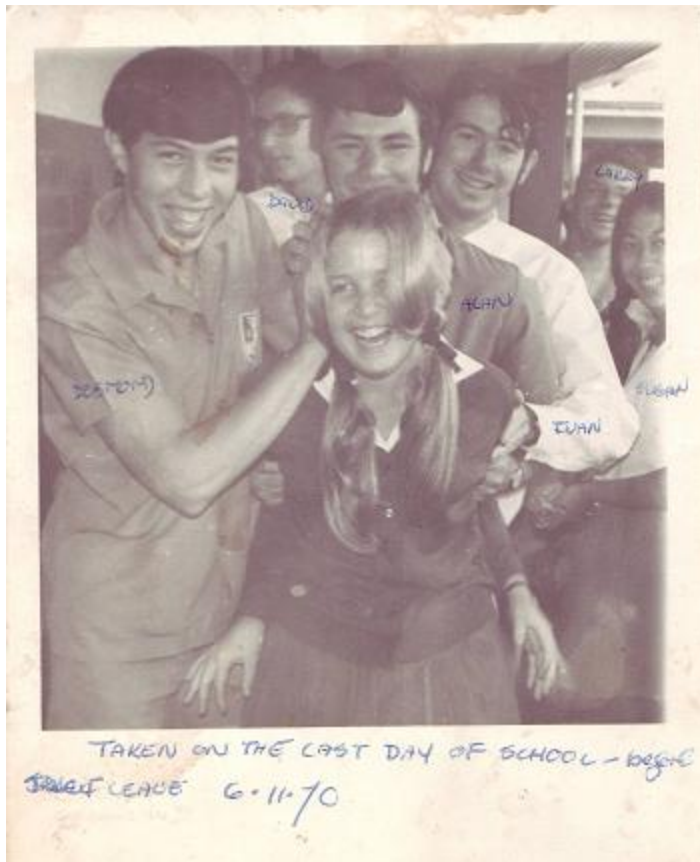
At the very bottom of the first page is an article entitled, "Long Short Story of Masada" that was written by my highly literate mother Zena, but it is very doubtful you will find another article my very quick reader, quick study, highly mathematical logical thinking mother wrote despite how very clear she was in her memoirs, "From the earliest days of 1949 she [Zena] visited Israel two and three times a year writing reports for different publications."

Let's just quickly look at a photo I doubt anyone apart from my immediate family has seen before



Focus as well on the date, January 1968, approximately 18 months after Zena was tasked by a member of Senator Robert F. Kennedy's advance team to come with, "A list of people Robert Kennedy should not meet" when this soon to be assassinated second member of the Kennedy clan visited with us in Durban, South Africa back in June 1966 right after giving a rousing speech at the University of Cape Town, South Africa which my sister Kathy-Louise would later attend.

Below is a photo of Kathy on her last day of school at Carmel College, Durban; and you would know that us British-English first write the day followed by the month and year.



In November 1970, David Schmarman who you see wearing glasses with his head turned slightly away had not yet been “banned” by the brutal United States of America’s South African Apartheid Regime but he was certainly well on his way.

You will recall me mentioning time and again of the incident when Mike Sagorin who has yet to email you the information he said he would, not later than yesterday, was during his compulsory military service for the Apartheid Regime in again the 3 Branches of the United States Government’s most brutal South African Police Force that he happened to come across a Black South African who was stealing David’s motorcycle helmet, and after grabbing the kid by the scruff of the neck led him to David’s parents front door.

Again, at this time, just a handful of years later, maybe six, at the tops seven, David Schmarman was on the “banned list” and had very few friends, especially few if any Durban Jewish friends who could be counted on given how so very significantly co-opted-corrupted was the entire Durban, Jewish community who exalted the Lazarus clan of Durban North who like American Charles Engelhard were “open supporters” of the United States of America’s 3rd Reich’s Southern Division aka The Apartheid Regime who remained in power serving the best interests of mostly US business people for an uninterrupted period of some 45 odd years while the Armed Forces of the United States of America led by the CIA executed flawlessly one “smokescreen” regime change after the next to the point that “Gods” such as Bob Dylan and John Lennon were never once questioned what

they thought about how the Apartheid Regime were left alone while bombing millions of Vietnamese to smithereens, all "in support of our south east Asia policy".

David answered the door and immediately told Mike Sagorin to let the black kid go and not because it is very possible David recognized Mike from either Carmel College and/or when David and his younger brother Jeremy who was a year ahead of me at Carmel College high school attended our over-the-top opulent orthodox Jewish synagogue on the corner of Silverton and Musgrave Road, although I don't once recall either of the Schmarman boys "lowering themselves" to be in the company of the Lazarus Jewish Kapos who had the best seats in the house right behind Mike, his elder brother Cecil who was one year behind me at Carmel College and their one sister who were all seated next to their grandfather. As best I recall either their mother or father passed away at a very young age.

David Schmarman didn't need to attend university to know that the black kid was stealing bread money in the United States of America's void of a "value system" South Africa, no different to what has been going on for century now here within the United States of America.

Mike Sagorin, was "duty bound" and despite the pleas of David who Mike knew was "under house arrest" Mike handcuffed the black kid and took him to jail.

During the criminal trial David Schmarman appeared in court and begged the judge to let the black kid go but to no avail and the black kid ended up serving a prison sentence and for all I know as well as what Mike Sagorin probably knows that kid could have been killed in jail if for no other reason than give David Schmarman and Co. "a lesson they wouldn't forget".

When I spoke with Mike Sagorin last week he was having great difficulty remembering a lot of things and of course I did NOT bring up this helmet incident.

You may recall me mentioning that my very athletic mother Zena never once skied, but below you see a photo of all of us apart from my sister Kathy-Louise who was on a 4 month Ulpan in Israel at the time, holding up her pair of skis.



When you next to communicate with my eldest brother Neil who you see on the far left, appealing to his poetic and sense of injustice ask him how many times he recalls seeing our very busy, night and day mother on the slopes of Kitzbuel, Austria.

Below is a photo of the cockpit of a Kittyhawk that my father flew on each one of his 71 odd missions dive bombing the crap out of the De Beers Nazis bastards.

Dear Jeff Klein - Campus Minister, University of Pennsylvania Newman Center,

The very same email which I exposed the culpability of the United States government and the intimate relationship with De Beers Anglo American's unregulated untraceable diamond currency and why it is that a known monopolist such as De Beers Anglo American has been allowed to allocate the world's natural resources for more than 100 years. the very clear chronology of the a brief history of money creation (which can also be found on just3ants.com):

1899-1902: Anglo-Boer War; British Imperialism lead by Cecil Rhodes founder of De Beers Consolidated Mines took control of South Africa sitting atop the world's most mineral rich lands.

1907: A contrived shortage of currency liquidity by bankers caused a stock market crash known as the Panic of 1907, JP Morgan and his banks "saved" the situation by providing liquidity, further justifying the need for central banking system as opposed to the competing trusts.

1913: The Federal Reserve System, comprised of 12 private banks intended to coordinate a dynamic currency is passed by the US Congress in a late night session on December 23, when many Congressmen were absent, celebrating the holiday with their families. JP Morgan and JD Rockefeller were the primary benefactors the US Federal Reserve having ownership/control of the majority of the newly formed central banks.

1914: Outbreak of World War I; financed in large by JP Morgan (US\$12 million to Russia and US\$50 million to France)

1917: JP Morgan along side Ernest Oppenheimer co-found Anglo-American Corporation.

1929: Ernest Oppenheimer uses a stock pile of diamonds to threaten De Beers Consolidated mines with crashing the diamond market and is named Chairman of De Beers, thus forming De Beers Anglo-American.

1933: President Franklin Roosevelt illegally using wartime authority, to outlaw the ownership of gold and forces all US citizens to hand over any gold in excess of \$100 to the Federal Reserve in exchange for paper currency.

The Formation of the Federal Reserve took the control of the issuance of money from Congress and placed it with private banks.

The Formation of De Beers Anglo-American created a powerful untraceable currency that could usurp the control of any government or regulatory agency and resulting with an aristocracy that could bypass the detection of the masses.

Thomas Jefferson (Letter to James Monroe, January 1, 1815)

"If the American People ever allow the banks to control the issuance of their currency, first by inflation and then by deflation, the banks and corporations that will grow up around them will deprive the people of all property until their children wake up homeless on the continent their fathers occupied. The issuing power of money should be taken from the bankers and restored to Congress and the people to whom it belongs. I sincerely believe the banking

institutions having the issuing power of money are more dangerous to liberty than standing armies.

We are completely saddled and bridled, and the bank is so firmly mounted on us that we must go where they ill guide.

The dominion which the banking institutions have obtained over the minds of our citizens...must be broken, or it will break us."

Assuming that your ignorance of history transcends all topics, I will spoon feed you some additional "meat" to chew on. As you see in the pictures below, the deafening silence of the Catholic Church during World War II was not always so silent.





Furthermore you are of course aware of the relationship between Croatian Politician, Ante Pavelic and Pius XII during World War II.

On April 25th 1941, following his seizure of power, Pavelic decreed that all publications, private and public, of the Cyrillic script were banned. In May 1941, anti-Semitic legislation was passed, defining Jews in racist terms, preventing them from marrying "Aryans". One month later all Serb Orthodox primary and preschools were closed. As soon as Pavelic had taken power, the Catholic Church in Croatia began compelling Orthodox Serbs to convert to the Catholic religion. But this was, as pointed out by Cornwell, a highly-selective policy: the fascists had no intention of allowing Orthodox priests or members of the Serb intelligentsia into the religion - they were to be exterminated along with their families. However, for those Serbs who were forced to convert, there was no immunity or protection from the Catholic church when the "bloodletting" of the fascist terrorist group, Ustashe began, as indicated by the speech made by the Croatian Nazi Mile Budak, who was a Minister in the Ustasha regime in Gospic, Bosnia during July 1941:

"We will kill one part of the Serbs, the other part we will resettle, and the remaining ones we will convert to the Catholic faith, and thus make Croats of them"

Mile Budak was talking about something that had already started: In an example of savage butchery carried out in the village of Glina on May 14th 1941, hundreds of Serbs were brought to a church to attend an obligatory service of thanksgiving for

the fascist state of Croatia. Once the Serbs were inside, the Ustashe entered the Church armed only with axes and knives. They asked all present to produce their certificates of conversion to Catholicism - but only two had the required documents, and they were released. The doors of the church were locked and the rest slaughtered.

A person can use any words to speak of their intentions but actions and often more importantly inactions are more transparent and honest.

Incidentally is 10% gross from all sources of income still the accepted tithe to the Catholic Church and if so can you please provide a calculation of the total sum of monies collected from the forced conversions in Croatia both before and during World War II? And while you are at it please also provide the same said calculations for the forced conversions from the 9+ crusades.

Of course you must not forget to subtract the loss of the Catholic parishioners that died fighting to convince the rest of the world that the ruling elite of the Catholic Church deserved their money in exchange for "absolution" of their sins which were of course defined by the same ruling members.

You are of course aware that the Catholic Church is not the only ruling party that has benefited from a class system and the division of education and awareness that is associated; but I would not seek solace in that association as you can only expect to find yourself more and more exposed as Moore's Law dictates the doubling of technology every two years and with it providing the spread of communication and associated transparency of people that have grown comfortable in usurping their limited authority.

Dear LtCol Mary Gould,

In order to answer your question/statement I must first explain why Israel attacked the United States most advanced Navy spy ship, the USS Liberty during their Six-Day war against Egypt, Jordan, Syria and aided by Iraq, Pakistan, Libya, Algeria, Morocco, Kuwait, Saudi Arabia and the United States.

The world and more importantly Israel's "ally" the United States, watched as Egypt, Jordan, and Syria amassed their military ground forces along their respective Israeli borders in preparation for a coordinated attack.

On June 4, 1967, the day before the start of the Six-Day War, Israel asked if the United States had any ships in the region. The U.S. said it did not, and sent a Jewish United States Ambassador, Goldberg to announce in the

United Nations that the U.S. had no ships within 350 - 400 miles of the region.

Early in the hours of June 5, 1967, the Israeli Air Force launched a preemptive strike against the airfields of Egypt which had the most advanced aircraft out of the attacking Arab forces. They flew below Egyptian radar detection and wiped out over 300 Egyptian aircraft and 100 Egyptian pilots. They repeated similar attacks in Syria and Jordan later in the same day.

During the attacks the Arab forces that were now scrambling to regroup changing their offensive posture to desperation resulted in their break of protocol and radioing a US naval spy ship for assistance. When Israel intercepted the communication they ultimately found that the previous statement by US Ambassador Goldberg was not only false but was intended to misdirect Israel and the world to the role that the US was playing in the affair.

On June 8, 1967, the Israeli Air Force comprised of two Mirage IIIs, firing cannon and rockets, followed by two Dassault Mysteres carrying napalm began attacking the United States' Navy's most advanced spy ship, the USS LIBERTY. Approximately 20 minutes later 3 Israeli torpedo ships arrived with gun fire and five torpedoes.

United States Investigation:

U.S. congressional investigations and four other U.S. investigations were not investigations into the attack, but rather reports using evidence only from the U.S. Navy Court of Inquiry, or investigations unrelated to the culpability of the attack but rather discussing issues such as communications. The U.S. Navy Court of Inquiry is the only investigation on the incident to date. They claim it was hastily conducted, in only 10 days, even though the court's president, Rear Admiral Isaac Kidd, said that it would take 6 months to conduct properly. The inquiry's terms of reference were limited to whether any shortcomings on the part of the Liberty's crew had contributed to the injuries and deaths that resulted from the attack. Because of time constraints, only 14 survivors of the attack and no Israeli personnel involved were questioned.

Israel's Investigation:

The Israeli military court of inquiry acknowledged that their naval headquarters knew at least three hours before the attack that the ship was "an electromagnetic audio-surveillance ship of the U.S. Navy" but concluded that that information had simply "gotten lost, never passed along to the ground controllers who directed the air attack nor to the crews of the three Israeli torpedo boats".

Later that year (1967), the United States navy began the construction of a swastika shaped naval barracks located on Coronado Island in San Diego California.

You may also find the following letter sent from President FDR to Ibn Saud, the head of the Saudi Royal Family shortly after their first meeting on February 14, 1945.

5 April 1945

GREAT AND GOOD FRIEND:

I have received the communication which Your Majesty sent me under date of March 10, 1945, in which you refer to the question of Palestine and to the continuing interest of the Arabs in current developments affecting that country.

I am gratified that Your Majesty took this occasion to bring your views on this question to my attention and I have given the most careful attention to the statements which you make in your letter. I am also mindful of the memorable conversation which we had not so long ago and in the course of which I had an opportunity to obtain so vivid an impression of Your Majesty's sentiments on this question.

Your Majesty will recall that on previous occasions I communicated to you the attitude of the American Government toward Palestine and made clear our desire that no decision be taken with respect to the basic situation in that country without full consultation with both Arabs and Jews.

Your Majesty will also doubtless recall that during our recent conversation I assured you that I would take no action, in my capacity as Chief of the Executive Branch of this Government, which might prove hostile to the Arab people.

It gives me pleasure to renew to Your Majesty the assurances which you have previously received regarding the attitude of my Government and my own, as Chief Executive, with regard to the question of Palestine and to inform you that the policy of this Government in this respect is unchanged.

I desire also at this time to send you my best wishes for Your Majesty's continued good health and for the welfare of your people.

FRANKLIN D. ROOSEVELT

Dear Senator Herb Kohl-Chairman Antitrust Subcommittee,

I read an article this evening about your public commitment to securitize
the Google-Yahoo deal, which had me a bit confused, and I was hoping
that you could clarify.

According to the Sherman Antitrust Act, "Every person who shall

My confusion is however not with regards to this specific action by the House, but rather their/your inaction with regards to a well known monopolist, De Beers Anglo American.

It is my understanding that despite multiple cases filed by the US Justice Department against De Beers Anglo American, the diamond monopolist has still been allowed to operate and sell their price fixed diamonds in our country; Their in lies my confusion as it appears to conflict not only with our Sherman Antitrust Act, but additionally it appears to highlight the the culpability of the US Justice Department, the Senate, and more over you and your Antitrust Subcommittee which I assume by the title focuses primarily on antitrust matters.

By the way, how much are you compensated to chair the Antitrust Subcommittee?

You are of course familiar with the FBI Agent, Robert Hanssen; The following cut and pasted from Wikipedia.com:

Hanssen was arrested on February 18, 2001, at Foxstone Park near his home in Vienna, Virginia, charged with selling American secrets to Moscow for more than \$1.4 million in cash and diamonds over a 22-year period. On July 6, 2001, he pleaded guilty to 15 counts of espionage in federal court. He was subsequently sentenced to life in prison without parole. Additionally further incriminating the US Justice system which is appearing more and more to be an oxymoron, is the CIA recruitment of Allard Lowenstein as a middle-man and creating a nexus between the CIA and De Beers through companies such as "United States-South Africa Leadership Exchange Program", "Peace for Freedom", "International Development Foundation", and "Price Fund".
