Dear David,

The email I sent your mother earlier was rather hastily written but mindful of the many other things I am doing with my time right now which I consider no more precious than anyone else's, but at the same time, I am loathe to waste anyone's time including yours.

Bottom line, attached is a series of emails between myself and the General Manager of <u>A</u>merican <u>E</u>agle, a wholly owned subsidiary of American Airlines.
