
Dear Gary:

2. Application of Law to Facts

National publicity followed the announcement of the **jury** verdict in December of 1996. *See, e.g.,* Diana B. Henriques, *Big Jury Award in Injury Case Over Keyboards*, N.Y. Times, December 10, 1996, at D1; Jon Auerbach and Laura Johannes, *Digital Equipment Loses Verdict on Carpal Tunnel*, **Wall St. J.**, Dec. 10, 1996, at B4. **The news of Ms. Geressy's nearly \$5.3 million verdict against defendant reached Gary S. 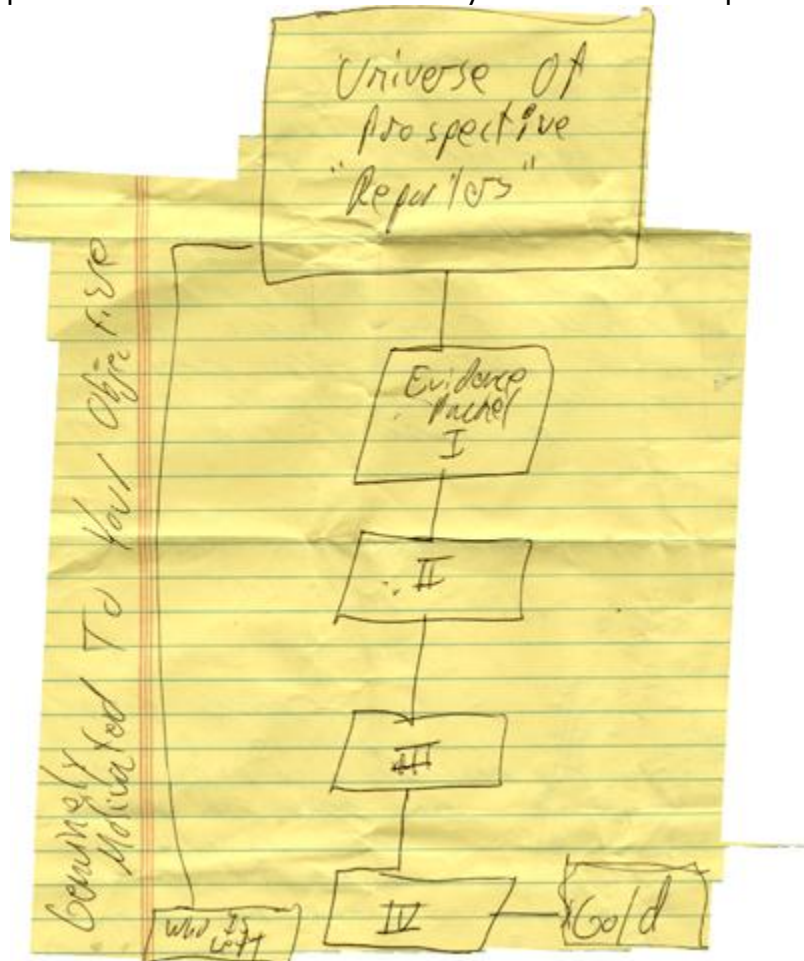

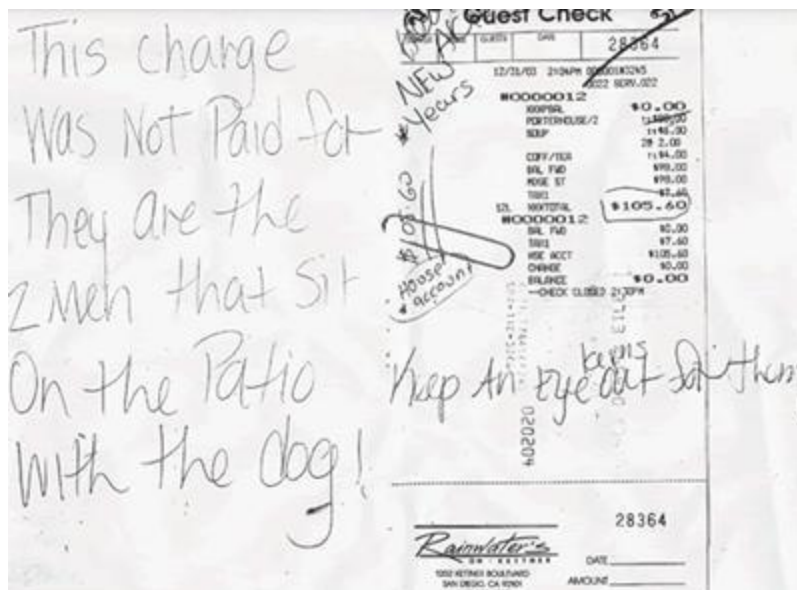
