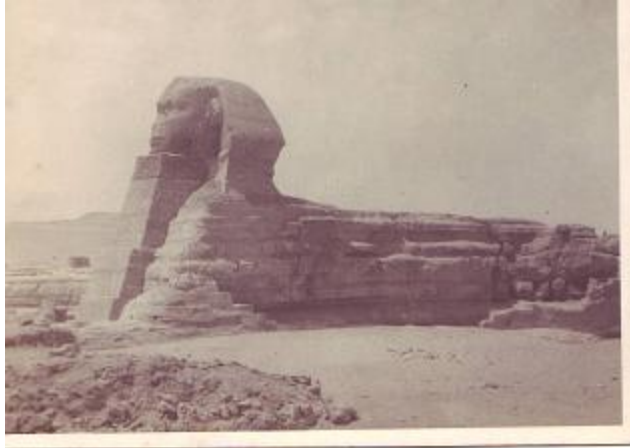
While sharing our respective "shared energies" of course I had to mention my need to now bring in Dr. Laura.

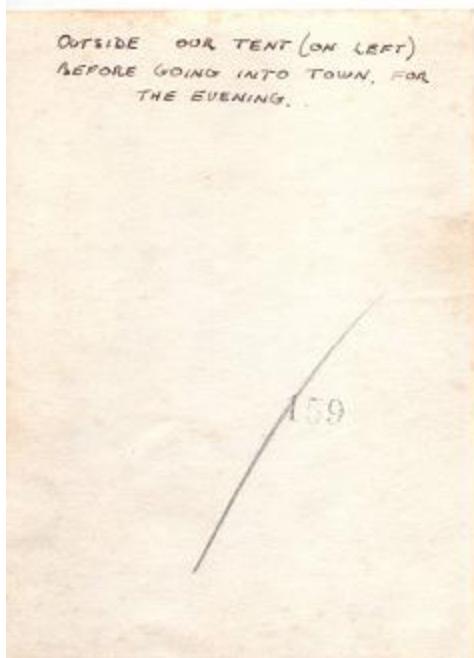
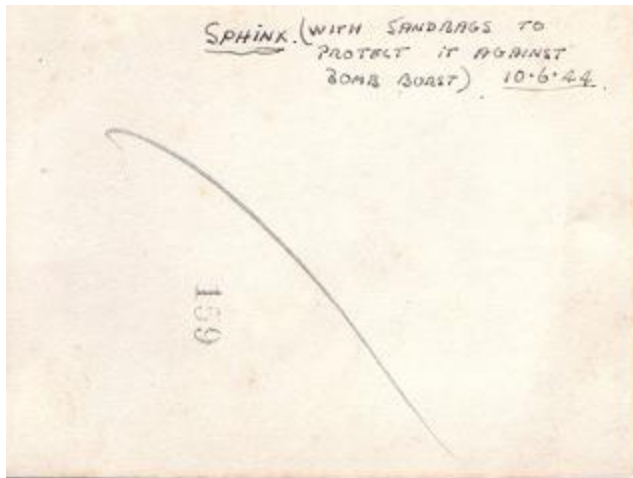
Continue to focus on the impact of my follow up to Rick Brooks of the Wall Street Journal.
