
Dear Gary:

When you can't beat them join them!



2. Application of Law to Facts

National publicity followed the announcement of the jury verdict in December of 1996. *See, e.g.,* Diana B. Henriques, *Big Jury Award in Injury Case Over Keyboards*, N.Y. Times,

December 10, 1996, at D1; Jon Auerbach and Laura Johannes, *Digital Equipment Loses Verdict on Carpal Tunnel*, Wall St. J., Dec. 10, 1996, at B4. The news of Ms. Geressy's nearly \$5.3 million verdict against defendant reached Gary S. Gevisser, Chief Executive Officer of Sunmed, Inc. (formerly known as Injury Evaluation Consultants (IEC)) in Las Vegas, Nevada.
