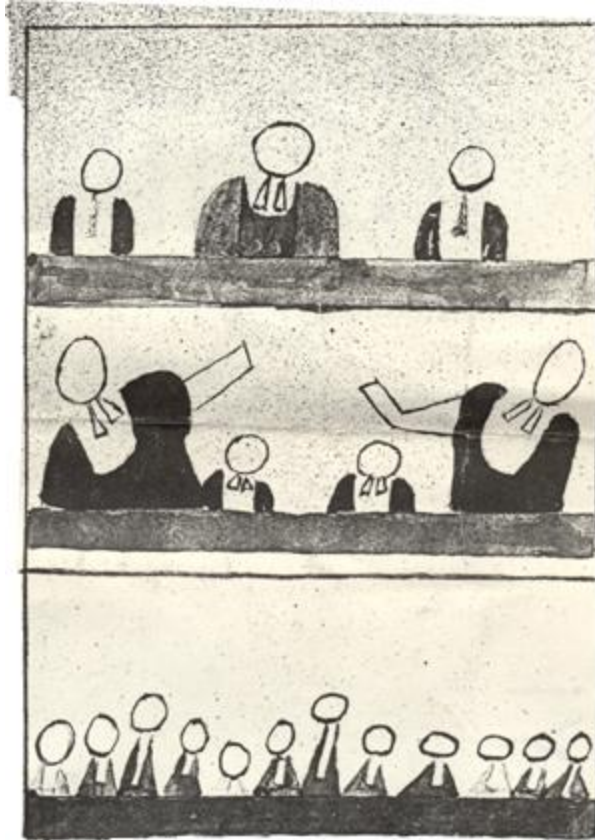
Adam - please forward to Mike Sagorin all the t-shirt designs even if they are not quite ready for production so that Michael can give his input.
