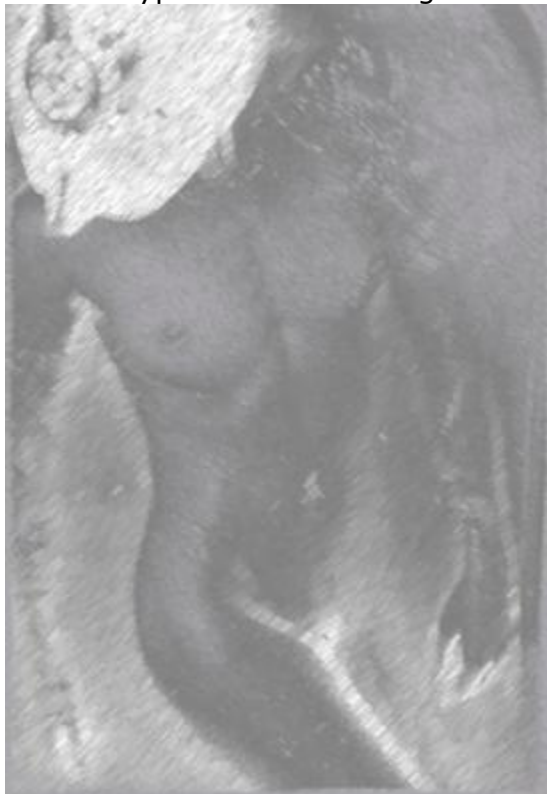
be abusive most of all to the person trying to get you to do the right thing and the smart thing which is also the right thing.


Dear Gary:

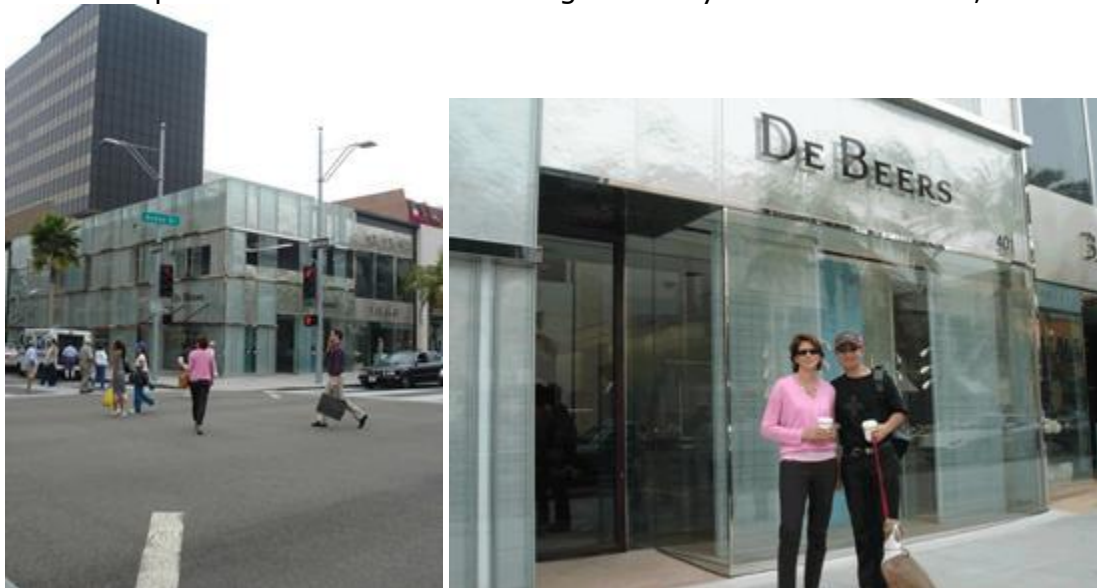
