Hey Scott, I'm sure by now you have heard that Julia and I are getting a divorce.

I ended up getting into some pretty major financial debt; without getting too into details, Julia was willing to forgive me from hiding the debt from her, but it gave us an opportunity to reevaluate our relationship, since we would be starting from scratch.
